REPORTS OF STANDING COMMITTEES:

Recreation: Chairperson Freeman reported the following: Received two quotes from Mr. Haywood on uniforms and portable field goals, \$4,800.00 and \$4,549.98.

Lighting portable on tripod will be provided by Mr. Haywood. Lights can run off power cord from library or by generator if needed.

Uniforms on hand and 2-sided banner for Triana Football & Cheer. Registration opens Aug. 6-12 this can be done on line at www.trianawarriors.com.

Website is up and running under construction, still waiting on 501C-3

Motion by M. Freeman to approve \$ 4,800 purchase for a dual goal post, C. Whitman seconded the motion. Motion carried.

Finance: Utility truck will cost \$34,912 to use for water department. Motion by Freeman to purchase 2020 Ford 250 Utility Truck to be equipped with tool box, flashing lights and signage estimated cost of \$36,000, Ragland seconded the motion. Motion carried.

Utility: Chairperson Ragland stated town needs to look at pumping water out of field. Mayor stated she contacted Commissioner Haraway when he came out the street was not flooded. She stated she informed him when flooding gets worse they will discuss what plan to do to put land back the way it was. The situation is sensitive because flooding is on both private properties. The County cannot

go on private property and we can't as a City go onto private property either.

Streets and Cemetery: Chairperson Whitman reported we need to purchase a couple of street signs for Savannah Subdivision, we will be reimbursed.

Mayor stated Mr. Whisda needs to purchase his own signs.

Mr. Whitman stated they are proposing to have people sit out in vehicles in the parking lot at the Tornado Shelter before the storm.

Mayor stated that is kind of in line with what others are doing.

Whitman stated airflow maybe a concern.

Ms. Freeman suggested we have the workers go up and sterilize storm shelter.

Mayor stated workers have already done that.

Fire & Police: Mayor Caudle reported Officers practiced at firing range. Officer Mayfield started the refresher academy she has been notified he will graduate early due to coronavirus.

Impala picked up from shop. Have an applicant who has applied Chief Powell to set up phone interview if that goes well then we will go from there.

Officers logged 1016 miles, made 15 traffic stops, 14 warning citations, and 7 citations, 24 calls for service, 1 arrest and 7 reports.

Ordinances, Resolutions, Orders and Other Business:

Attorney Caleb Ballew will get with Attorney Brian Williams and review the town's cleanup Ordinance.

Council approved purchase of a trailer to haul equipment on.

Mayor Caudle stated it was discussed in the work session to hire the towns building inspector full-time, discussion no action taken.

Code Enforcement Officer Duties discussed, no action taken.

Councilman Ragland stated the last two employees we hired in the Maintenance Dept., can do that job. Councilman Whitman stated we need someone qualified to work with the Prosecutor and Judge to do that job.

Public Comments:

Tim Melon a resident of Bridge mill Subdivision stated they have no street lights on their street and the streets need cleaning. They have contacted their HMO and nothing has been done.

Mayor stated we no control over their HMO for him to call the developer to clean streets.

Councilman Whitman stated contractors working in Brookhaven subdivision have dumpsters in the street can't get around it.

Mayor asked the Attorney to draft a letter and send to all developers to remove the dumpsters from the streets.

Mayor stated auditors dropped off audit reports they will come back at a later date to go over report. She stated she will look at going out on bids to hire another audit firm once they finish this next report.
