

**ORDINANCE No. 2018- 12**  
**MODIFICATION OF BUSINESS LICENSE FEES;  
MOVING & STORAGE BUSINESSES**

WHEREAS, the Town Council of Triana has a compelling interest in setting, regulating, and modifying licensing fees for persons and entities doing business within the Town of Triana;

WHEREAS, there is a single fee for all types and classifications of businesses operating in Triana, Alabama;

WHEREAS, the Town Council of Triana believes it to be in the best interest of the Town to modify this business license fee for moving and storage companies that are principally located within the Town of Triana;

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF TRIANA, ALABAMA AS FOLLOWS:

**Section 1 – Title**

This Ordinance shall be known as the “Modification of Business License Fees; Moving & Storage” for the Town of Triana.

**Section 2 – Incorporation**

The recitals set forth above are incorporated into this ordinance as the findings of the Town Council.

**Section 3 – Purpose**

The purpose of this ordinance is to promote and regulate commercial activity within the Town of Triana.

**Section 4 – Scope**

This Ordinance shall only apply to those businesses and companies whose primary function is moving services and/or storage services. Any provision of a previous ordinance regarding business license fees that is not specifically and expressly modified by this ordinance shall remain in full force and effect.

**Section 5 – License Fee Modification**

The business license fee for those persons and entities principally located within the Town of Triana and operating a moving service or storage service business shall be modified to \$225 per year. No other provision or procedure regarding business licenses shall be modified for moving and storage service businesses.

Section 6 – Exclusions


This Ordinance shall not apply to the following businesses:

- (a) Towing or wrecker services
- (b) Auto repair or body shops
- (c) Car and/or boat storage
- (d) Crop or livestock storage
- (e) Any other business whose primary service is not either moving or storage service.


Section 7 – Severability

In the event any section, subsection, sentence clause or phrase of this ordinance shall be declared or held invalid or unconstitutional by any court of competent jurisdiction, such holding shall in no manner affect the other sections, sentences, clauses or phrases of this ordinance, which shall remain in full force and effect, as if the section, subsection, sentence clause or phrase so declared or held invalid or unconstitutional were not originally a part thereof.
