## ORDINANCE NO. 2020- 4

## AN ORDINANCE OF THE TOWN OF TRIANA, ALABAMA FOR THE SETTING OF QUALIFYING FEE

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF TRIANA, ALABAMA, AS FOLLOWS:

SECTION 1. That the qualifying fee for all candidates seeking election as Mayor of the Town of Triana for the 2020 election be fixed at \$\_50.00\_.

SECTION 2. That the qualifying fee for all candidates seeking election as a councilmember of the Town of Triana for the 2020 election be fixed at \$ 25.00.

<u>SECTION 3.</u> Such qualification fees shall be paid to the city clerk and deposited to the general fund of the Town at or prior to the time of taking out qualification papers by any such candidates.

<u>SECTION 4.</u> Any person desiring to qualify who is not financially able to pay the required fee may qualify provided such prospective candidate furnishes the clerk with an affidavit stating that he is financially unable to pay the required fee fixed by this ordinance.

SECTION 5. This ordinance is adopted pursuant to <u>Code of Alabama</u> 1975 §11-46-2 and shall be effective in all elections, both general and special, for aforesaid offices from and after the date of adoption.
